## REQUIREMENTS FOR MANUSCRIPTS OF ARTICLES ACCEPTED FOR PUBLICATION IN THE JOURNAL

- 1. Materials not intended for publication in other publications are accepted for publication.
- 2. The article must contain the following details:
  - index of the Universal Decimal Classification of literature (UDC) (affixed in the upper left corner);
  - title of the article (in Russian and English);
  - Surnames, first names, patronymics of all authors in full (in Russian and English) with indication of academic degree, title and position;
  - full name of the organization with indication of the city (full and abbreviated version) (in Russian and English);
  - abstract (consists of 20-70 words, placed under the name of the organization, written in italics); the abstract is given in Russian and English;
  - citation is not allowed in the abstract:
  - 3-4 keywords are allocated in a separate line (in Russian and English);
  - the text of the article (7-12 pages, margin sizes: left 30 mm, top and bottom 25 mm, right 15 mm, paragraph 1.25 cm, line spacing 1);
  - Page format B5(17.6 x 25 cm);
  - endnotes and arrangement of pages in landscape format are not allowed in the text of the manuscript;
  - references (bibliographic references are given at the end of the text in alphabetical order by automatic numbering of the list, the text in square brackets indicates the serial number according to the list of references and the page, for example, [5, C.121]). In-text, subscript and out-of-text bibliographic references (references) should be issued in accordance with GOST R 7.05-2008 "Bibliographic reference. General requirements and rules of compilation", for example:

- 3. The article is presented in printed on paper and in electronic form.
- 4. When typing, the Times New Roman font is used (size 12 pt, line spacing -1), there is one space between the words in the entire text, the quotes are straight " ".
- 5. Illustrations are made in graphic editors in the form of black-and-white graphic files as a single object. All illustrations are accompanied by captions (not repeating phrases-links to drawings in the text), including the number, title of the illustration and, if necessary, symbols.

Be sure to include a link to a drawing or table in the text, for example: (Fig. 1, Table 1)

Drawings are made in accordance with the following requirements:

- image scale the smallest (subject to readability);
- the alphabetic and numeric designations in the figures in outline and size must correspond to the designations in the text of the article;
- the size of the drawing is no more than 10x15 cm;
- text information and symbols are transferred from the figure to the text of the article or captions.

Design: Figure 1 – The name of the figure. It is located in the center, the font is bold. Located under the drawing. No dot is placed after the name of the drawing. Table 1 – The name of the table. It is located in the center, the font is bold. It is located above the table. No dot is placed after the table name.

- 6. The terms and definitions, units of physical quantities used in the article must comply with applicable national or international standards. Formulas should be numbered in parentheses, for example, (2). Values indicated by Latin letters, as well as simple formulas are typed in italics, more complex formulas are performed using the formula editor of the MS Word program.
- 7. The last page of the manuscript must be signed by all authors. The articles of students, applicants and postgraduates, in addition, must be signed by the supervisor. When publishing articles of graduate students, applicants for the degree of Candidate of Economic Sciences, a recommendation of the department should be submitted.
- 8. The editorial board does not inform the authors about changes and abbreviations of the manuscript that are editorial in nature and do not affect fundamental issues.

- 9. There is no fee charged from graduate students for the publication of manuscripts.
- 10. The final decision on the approval or rejection of the material submitted to the editorial board is made by the editorial board and is final, about which the authors are informed.
